I leave my / X share (s) of my residuary estate for the National Rheumatoid Arthritis Society, Beechwood Suite 3, Grove Park Industrial Estate, White Waltham, Maidenhead, Berkshire, SL6 3LW registered charity number 1134859 (England and Wales)/ SC039721 (Scotland), absolutely for its general charitable purposes and I declare that the receipt of the treasurer or other proper officer for the time being shall be a sufficient discharge to my executors.
