- If there are any chages to the amount, date oe interval of your Direct Debit Go Cardless re NRAS will notify you 3 working days in advance of your account being debited or as otherwise agreed. If you request Go Cardless re NRAS to collect a payment, confirmation of the amount and date will be given to you at the time of the request.
- If an error is made in the payment of your Direct Debit. by Go Cardless re NRAS or your Bank or Building Society, you are entitled to a full and immediate refund of the amount paid from your bank or building society If you receive a refund you are not entitled to, you must pay it back when Go Cardless re NRAS asks you to.
- You can cancel a Direct Debit at any time by simly contactiong your Bank or Building Society. Written confirmation may be required. Please also notify us.
